Reference Note:

The applications for Ph.D. Entrance Examination were invited vide Notification of even No. dated 6.6.2019 and Ph.D. Entrance examination was held on 29.12.2019. The merit list of the candidates appeared for Ph.D. Entrance was notified as per the provisions of clauses 4, and 9.1 & 9.2 of 2016 Ph.D Regulations of Bangalore University and UGC Ph.D. Regulations 2016. The 1st round of counselling was delayed due to lockdown on account of COVID-19 and other inevitable reasons. The 1st round of Counselling was held on 22nd of October, 2020. More than 400. Ph.D. seats are still vacant. Bangalore University vide. No EX.II/Ph.D/Regulation/2018-19, dated 16.10.2020 has adopted University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree)(1st Amendment) Regulations 2018, notified vide UGC Notification F. No. 1-1/2002 (PS) Exempt (PtF1.III) Vol-II dated 27th August, 2018. The same was ratified by the Academic Council at its meeting held on 30.3.2021.

The applicants for Ph.D course who have appeared for Ph.D. Entrance during 2019 have represented to the Syndicate on 24.03.2021. In the representation, the students have requested, among other things, (I) to allow a relaxation of 5% in marks by considering percentage of Marks secured in their P.G. examination and Entrance Examination put together as per proviso to Clause 2 of UGC Notification F. No. 1-1/2002 (PS) Exempt (Pt.F1.III) Vol-II dated 27th August, 2018, (2) to allow teachers less than two years of service to guide new Ph.D. students; (3) to increase No. of Ph.D. students per teacher by two numbers; (4) not to allow the students who were absent in the 1st Round of Counselling. At the outset, the Vice-Chancellor welcomed all the members for the meeting. He briefed that as per resolution of the Syndicate a Syndicate Sub-Committee was constituted with members of the Syndicate and Deans of Faculties to decide on the demands of applicants of Ph.D Course. The principals of Constituent Colleges, Special Officers and Prof. Sudesh, V have also been invited for the meeting. The representation submitted by the students with regard to Ph.D. admissions and copies of Ph.D. Regulations of 2016, Notification inviting application for admission to Ph.D. course during the year 2019, UGC (minimum standards and procedure for award of M.Phil/Ph.D. Degree) Regulations, 2016, UGC Regulations (1st amendment) 2018 were circulated among the

The Registrar (Evaluation) informed about the chronological events and dates from inviting applications for admission to Ph.D. course to conduct of 1st round of counselling for Ph.D. admission and representation of students.

Dr. Sudesh V also told that the decision to allow the students of P.G. courses for the entrance exam of Ph.D. couse was a collective decision and relevant provision can be interpreted in either way. There is nothing illogical in allowing the final year students to write the Ph.D. entrance examination. Now, we have to look into the future aspects. Prof. H.N. Ramesh has quoted the Court order wherein the Hon'ble High Court has directed to consider the representation of final year M.Tech students who had taken Ph.D. entrance for admission to Ph.D. course.

All members unanimously opined to take necessary decision in the interest of students' community to resolve the matter by making harmonious/beneficial constructions of University Ph.D. Regulations and UGC Ph.D. Regulations.

After detailed discussions, the Committee made the following recommendation on the representation of the Students:

- The Committee recommends that a relaxation of 5% of marks (from 50% to 45%) shall be allowed for the candidates belonging to SC/ST/OBC (non-creamy layers)/Differently-abled category. The percentage of marks secured in their P.G examination and Entrance examination put together be taken while allowing 5% of relaxation as per Proviso to Clause 2 of UGC Notification F No. 1-1/2002(PS)Exempt(Pt.F1.III) Vol.II dated 27.8.2018, as a special admission drive.
