As such, the syllabus of the various aspects is revised as per the needs of the departments and subjects, as felt in the meetings of the Board of Studies (BOS) in each subject. In view of introduction of CBCS system, the University revises, restructures and update the syllabus once in 3 years of both UG and PG courses. Keeping the views and the needs of the society and the Global competition, the undergraduate courses have been restructured to give a holistic approach and to introduce skill development courses to improve the employability of our graduates.

IQAC is striving to activate several university systems to enhance the facilities meant for the main stake holders- the students. The Library, ICT wing, Engineering sections, students welfare sections have been requested to be vigilant and active in providing student friendly measures. Student facilities at Departmental levels and sensitising programmes for students have also been initiated. Support for sports, cultural and other extra-curricular activities have also been activated.

5.2 Efforts made by the institution for tracking the progression.

The Vice-Chancellor, Registrar and Registrar (Evaluation) of the University periodically meet the students to track the progression. Meetings are also held with Heads of the concerned wings/Department/sections to ascertain the effectiveness of the student's facilitative system. When found inadequate, appropriate actions are initiated to rectify the areas of default. The assessment of teachers, department and infrastructure available to students would further help the University to track the progressions. 6.2 Does the Institution have a Management Information System:

The University dissipates its information through its websites. A well-established mechanism at the office of all the executive officers like Vice-Chancellor, Registrar, Registrar (Evaluation), Director of PMEB ensure that all the necessary information that need to reach students, teachers and non-teaching staff reaches on time. Besides, the individual departments have their own arrangement of dissipating necessary information and notifications to students.

6.3 Quality improvement strategies adopted by the institution for each of the following:

Curriculum Development:

Several significant actions were taken and reforms made to improve the curricular aspects of the university, keeping in view the ever-changing global higher education scenario, without sacrificing the local needs. The spirit of National Education Policy, industrial requirements and local needs were considered while introducing new courses and reviewing the existing courses.

6.3.1 Teaching and Learning:

The University conducts periodic training programs on adopting new technologies of ICT to better equip the teachers to have Computer and internet access. In both the University campuses, Internet facilities are made available to researchers, academics, students and administration to use information and communication technologies.

The University encourages blended learning by using e-learning resources. The computer aided learning is given priority. The Wi-Fi internet and Cabled Internet Access is available in all the Departments, Library and in open spaces of the campuses to enhance the scope of e-learning. In addition, the University subscribes to CD-ROM databases facilitating quick e-survey of the literature by giving only keywords.

6.3.2 Examination and evaluation:

There are several criteria that the University utilizes in order to ensure that all the stakeholders are aware of the evaluation processes that are in place through the following measures. The evaluation issues concerning students are also made known well in advance at the time of their admission. Information pertaining to evaluation is also displayed on the University website so as to ensure that all stakeholders are aware of the evaluation processes. The calendar of events pertaining to all the events are announced well in advance.

6.3.3 Research and Development:

The research policy of the University has been very strong and has created a very conducive environment for research at departmental, faculty, research student and student levels, besides encouragement for pursuing research through intra-institutional and inter-institutional levels. The University has extended support for availing funding resources from national agencies, governmental, corporate and industrial sectors, besides its own funding support for student research.

The Research Administration and Consultancy Cell has been constituted by the University. This is based on the elaborate recommendation of a high level committee. The purpose of this cell is to reduce the bureaucratic hassels in expecting research progress.

6.3.4 Library, ICT and physical infrastructure / instrumentation:

Library implemented digitization of thesis and dissertations submitted to Bangalore University which are made available through a searchable CD provided with Infopack. University Library extended remote access service facilities by incorporating R3 Access software.

Library has introduced antiplagarism software to prevent copying of research and theft of intellectual property.

6.3.5 Human Resource Management:

- Smart cards have been issued to the college teachers to ensure effective utilization of their services for valuation work to announce the results within the stipulated time
- University also support the administrative staff to participate in outdoor activities as a measure to revitalize their commitments to work.
- Promotion (UGC-CAS) to teachers was also in the best interest of teachers and their commitment to work.

6.3.6 Faculty and staff recruitment:

Owing to the state Government ban/ freeze on new recruitments of staff, the University has not been able to appoint new staff, either teaching or non-teaching. However, to ensure that the work is not affected, the University has appointed Guest faculty for the P.G. Departments wherever necessary and persons on contract basis for non-teaching work as well. Some of the works were also outsourced.

6.3.7 Industry interaction / collaboration:

Establishment of career guidance and placement cell helped to open new vistas for Industry-Institution interactions. Students were benefited by the exposures they got with industrial experts at the time of their interaction in placement cell. Many experts from industries were invited to BOS of different subjects to share their experience and to derive useful inputs while framing curriculum.

6.3.8 Admission of students:

Admission to P.G. courses was made by the Central Admission Committee Constituted by the University. This committee involved senior professors in the concerned Departments besides senior administrative staff. The roster system was meticulously followed.

Elaborate arrangements were made to provide opportunity for all sections of the society. UG admissions were done at college level, by following the norms of the University and the State Government.

Admission to Ph.D. program were through an entrance test conducted by the University. Here also due consideration was given for all sections of the society and the admission to Ph.D. program is also processed, based on the availability of guides in a particular subject.

Janan Bharathi Campus of BU is gifted with natural wilderness amidst greenery is love acres of land spread in a huge space of Several measures like planting of tree saplings every year, conserving biodiversity, augmenting ground water, involving various stakeholder groups to conserve and enhance them have been initiated. Many programs as shown below pertaining to environmental conservation and eco sensitization are the regular features of Bangalore University:

- The University has chalked out program of recycling waste to compost and bio gas which will be utilized for the Bio-park plants and gas for cooking in the hostel.
- Roof – top solar power generators, a measure towards ‘green–clean’ campus is under process. A 250 KW solar power generation will be installed in the administrative block roof.
- Onsite Bio-diversity educational training for graduate and school students were carried out by experts from Department of Environmental Science.
- “Joy of knowledge” a program module for children was conducted by making students experience nature in the green campus of Jnana Bharathi of Bangalore University.

- Energy conservation : The university initiated certain steps towards exploring and providing opportunities for energy efficiency optimization schemes at all university campuses. Accordingly, incandescent light bulbs were replaced by cost effective, high efficient LEDs.
- Use of renewable energy : Plans are underway to use solar energy power in the campuses to reduce power consumption and use alternative sources of generating power which would help in overcoming the power crisis.
- Check dams were rejuvenated for their infiltration capacity. It enhanced the ecology of the campus
- Efforts for carbon neutrality: Implementation of e-governance by the university is one among the novel means to promote carbon neutrality in the campuses.
- Planting the new saplings in the campus like before was conducted this year also. Participation of campus students, garden department, school children, common public and NGOs was * laudable exercise.

This tool was rationalised, after comprehending the opinions of the teams who worked on Local Inquiry Committees to recommend affiliations to colleges to improve the objective assessment of the colleges. It was well revived by all the colleges and the assessment made more objective.

The parameters of the objective assessments of the colleges are as under:

Infrastructure Index (Max. Score: 65): *The main parameters* - No of class rooms, laboratory, computers, internet facility, library space, playgrounds, SC/ST book bank, rest rooms, auditorium, administrative offices etc.

Faculty Index (Max. To augment the resources as the State Govt. Block Grant support is inadequate. 4. Attracting foreign students to the different academic programs including research degrees.

5. Plans of institution for next year.

1. **Introducing the School concept in PG Programs:** The University has initiated measures to establish Schools by amalgamating related disciplines /subjects under one umbrella to propagate a better and much needed interdisciplinary course studies and research.
2. The present CBCS structure would be rationalized to adopt more and more skill-based and vocationalised curricula to enhance the elective options at the PG level. The UG programs would be further restructured for enhancing vertical and horizontal mobility of learners so that a holistic approach is realized and sustained.
3. **Introducing more Vocational Courses:** The University has chalked out plans to introduce vocational courses at UG level, besides their regular courses, to equip them with multifarious skills / knowledge to make a better career and to produce students as job creators rather than job seekers. This would be achieved by introducing a compulsory vocational subject in lieu of one of the optional subjects.
4. **Nurturing cross-disciplinary Research:** Inter-and trans-disciplinary research projects in science, humanities, commerce, management and law would be supported by the University with more rigour and financial support.
5. **Strengthening of the Placement Cell:** Every Department will be given more impetus to make their placement units more effective, besides the Central Placement Cell of the University which will be fully supported by providing adequate staff, funding and space. Better industry/corporate interactions and participation, will be ensured to make the Placement Cells more vibrant for meaningful benefit to the students.
6. Establishing Institutional Information network for effective procuring, processing and dissipation of data which is vital for the growth of the University.
7. Accomplishing the task of establishing Research Administrative and Consultancy Cell, for the effective and hassle-free movement of files related to research projects as well as to encourage consultancy activities in the University.
8. Finalizing the matrix of the teachers for better reflection of the University performance.
9. Reviving the research journals and bulletins of the University.

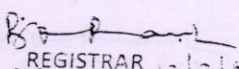
