All the courses offered by Bangalore University are developed with the careful understanding of local, regional and global development needs. Each course curriculum is updated with the professional skill requirements and over all development needs of the students. Every course syllabus has the specification of course outcome, programme specific out come and currier opportunities. Bangalore University has started 16 new courses keeping advancements in the various fields, skill requirements, job opportunities, employability and the challenges emerged time to time. The new courses initiated with the government approval since the year 2019 are B.Sc. Honors in Agricultural Skill and Entepreneurship, B.A. and M.A. in Criminology, M.Sc. in Food Technology, Bio-Informatics and Biotechnology, Human Disease Genetics, Food and Nutrition, Economics, Solid Waste Management, Film Making, Graphics and Animation, Criminology and Forensic Science, Disaster Management and Medicinal Botany, M.A. in Tibetan Literature, Tibetan Language, Buddhist Philosophy, Tibetan History, Interdisciplinary Indian Classical Music Research, Advertising and Public Relation, Media studies, P.G. Diplomas in Manuscriptology & Palaeography, Interdisciplinary Studies in Indian Classical Music, Auditory Verbal Therapy Course, Film Acting, Theatre Arts, Film making, Agricultural Management, Swami Vivekananda Studies, Buddhist Studies, Professional Diploma in Bharathanatyam, Odissi, Certificate Courses in Research Methods in Manuscriptology and Palaeography, B.Sc. (Honours) in Physical Science, B.A. (Honours) in Liberal Arts.

University has incorporated many skill based job oriented courses at under-graduation level too. With the vision of enhance the employability and the orient students to resolve many challenges faced at local regional and global level. Bangalore is the hub of various professional possibilities. By identifying the future needs and cater to the professional skill requirements, various professional courses which are different in nature comparing to traditional courses are initiated and successfully running. Further traditional courses are updated with latest skill and knowledge generation objectives.

Further university has started under graduate honors courses with multiple entry and multiple exit options and National Education Policy guidelines. Under NEP university has initiated new under graduate subjects based on professional and skill requirements.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

Bangalore University integrates cross-cutting issues of the society like moral ethical and human values along with professional ethics in the syllabus. Gender equality is taken care with various initiatives. Environmental awareness is created through extension activities by the Post graduate departments and echo clubs in the affiliated institutions. To enhance the moral values among the students, university has conducted orientation to the teachers of all affiliated colleges to incorporate value based education curriculum as short term training programme for the students. Professional ethics is part of every course syllabus. University celebrates various national international days such as women's day, human rights day, yoga day to name few meaning fully by organizing relevant seminars and workshops in all the PG departments.

University has Anti Sexual Harassment cell. to provide counseling to students, promote gender equity among students and also deal with related issues of safety and security of female students, staff and faculty. The university campus is secured with CCTV and high level security. There are separate Boys & Girls hostel (In-campus) for providing the safe environment to all students. Workshops, panel discussion and sensitization programmes are conducted to create awareness among girl students, female teaching and non-teaching staff. The text materials related to legal frameworks of gender equity and anti sexual harassments are distributed to all the students and staff. University has child care center. It has implemented transgender quota in University departments and affiliated colleges.

Environment study is integral part of all undergraduate programmes. Solid waste management is a new course started in the university. Curriculum demands experiential learning, industrial visits and project works related to environment and sustainability. Environment law, environment communication and climate change are taught in curriculum of various courses. Environment science department is involved in organizing awareness programmes such as echo friendly

Ganesh, eco friendly Deepavali, celebration of ozone day, environment day, wetland day, water day, biodiversity day etc.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The university has well-planned multi-level strategies that are implemented from time to time to address the issues of learning

levels. Mentoring is implemented at under-graduate and post-graduate level. Students are assigned with a teacher and senior students to get the academic support and speedup the learning. The induction training program conducted immediately after the admission. The orientation programmes will be conducted to provide basic understanding of the subject, professional possibilities and knowledge of skill requirements by the eminent academicians and professionals. Alumni are involved in motivating students. Since then, the students are trained by the respective faculty members during their course, catering to their needs and putting conscious effort to remove difficulties in studies.

The actual stratification of students into slow, average and advanced learners is based on their performance in the internal examination. Undergraduate courses are effectively implementing the mentorship and segregation of students into different learning levels. Teaching faculty, course coordinator and Head of the department takes up the responsibilities of providing necessary guidance and additional inputs to the students.

Special remedial classes are arranged for the slow learners before or beyond the regular class schedule on specific days for each course and individual attention is paid for improving the students' level of learning, problem solving and presentation.

Simultaneously, the needs of the average, progressive and advanced learners are taken care of by the concerned faculty through assignments, seminars, and more importantly peer-group discussions.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

Experiential learning, participative learning and problem solving methodologies are well adopted to ensure the holistic development of students and facilitate life-long learning and knowledge management.

Various courses offered at constituent colleges and Post graduate departments have incorporated participatory learning based on the demand of understanding the subjects. Students are allowed to participate in various training programmes by conducting special hands on training sessions and department level. Every post graduate course has the project work as part of curriculum. To enhance the participative learning, seminars, projects and model making are encouraged.

Participation in professional societal activities of IEEE, ACM, etc. for engineering, moot court for law and other relevant professional organizations activities. Soft skill training are imparted at regular intervals.

Industry interaction and the internships are made mandatory for the students. Social work, women studies, education students do regular field work and extension activities for experiential learning.

Industry projects and collaborations are undertaken to enrich students with pre-employment training. Periodical Guest lectures on topics relevant to employment skills by personnel from respective organizations/industry.

Experiential learning is ensured also through practical courses, encouraging students to take up innovative projects. Involving students in teacher's research work, organizing exhibitions etc.

Problem solving methodologies are adopted at every semester by incorporating quizzes, case study analysis, seminars and focus group discussions.

2.3.2 - Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year

Due to COVID enforced online classes followed by lock down has enriched the use of ICT tools and online materials. All the faculty of Bangalore University have regularly taken online classes without compromising with curriculum requirements. Online live classes, discussions, demonstrations; project monitoring and practical orientation was given to the students extensively during this year. All the teachers are technically equipped the skills of handling various online platforms, learning management systems and tapping online resources. Teachers used MOODLE, Insert learning, Wakelet, Flip grid, Google classroom, Zoom, Google meet, Microsoft teams etc. Teachers have prepared video lectures, interactive slides and other activities to enhance the student engagement. Faculty have been provided with demonstrations and training to handle online classes. Even after resuming offline classes faculty are engaged with students learning through online platforms such as uploading the assignments, group discussions, online tests, interactions, discussions, sharing materials etc.

ICT enabled Teaching-Learning Process is supported with Regular Practical Sessions, access to Digital Library, Online Courses (MOOCS, NPTEL etc.), online journals, Online tests, Use of LCD projectors for seminars and workshops, productive use of educational videos, and accessibility of non-print material for students of different disciplines. Faculty and students find ICT tools indispensable as they are used to it.

Bangalore University is always in the forefront for adopting novel technologies & implementing new methods in education .In this line University adopted technology in conducting examination & evaluation. The main objective behind this was to develop confidence in the stakeholders to achieve 100% outcome. The first step towards this initiative was digitization of Practical Examination.

I .PRACTICAL EXAMINATION

Looking into the constraints of earlier system we decided to scrap the OMR & digitize the entire practical examination process. With the available digital service provider a new in house team comprising of the Registrar (Evaluation) ,senior UG college teachers was formed and an online practical examination tool was developed.

1. Online QP indent was introduced so that there is no error when entering the paper name and paper code
2. Online Room Allotment & Online invigilation diary will reduce the error in entry of Absentees and ensure immediate result declaration
3. The University also found some irregularities in the result where outsourced (external) agencies were involved .Hence it has put a check on the process & developed foolproof digitization of evaluation & no error in totaling and other

procedures .

2.6 - Student Performance and Learning Outcomes

2.6.1 - The institution has stated learning outcomes (generic and programme specific)/graduate attributes which are integrated into the assessment process and widely publicized through the website and other documents

The Program Outcomes (POs), Program Specific Outcomes (PSOs) and Course Outcomes (COs) are framed by the department after rigorous consultation with all faculty and the stakeholders. These Pos and PSOs are formulated based on the students ability and skill enhance requirements to fulfill the professional and personal requirements. Program specific objectives are also in complaisance with expectations of respective professional bodies of the program such as UGC, AICTE etc. The syllabus, which has the incorporation of the programme objectives, program specific objectives and course objectives are displayed on the university websites and syllabus books of the respective programs. Pos and PSOs along with graduate attributes are made clear to the students at the time of admission. During induction program students orientation will be done in this regard. All the faculty are made mandatory to undergo induction program and refresher course. In these faculty development programmes faculty are exposed to the concept of outcome based teaching learning process. Parents' meetings are conducted to brief the parents about Cos, Pos and Gas.

Each course has a defined set of course outcomes and corresponding evaluation criteria. The course outcomes are mapped to the program outcomes which are used to provide the quantitative measurement of how well the program outcomes are achieved. The performance of the students in the examinations during the semester in each course is used to compute the level of attainment of the POs and PSOs through the mapping of questions to COs and COs to POs and PSOs. CO-PO & PSO mapping for all the courses in the program is prepared by the Board of studies in consultation with faculty members. The undergraduate course syllabus is prepared as per the requirements of National Education Policy implementation. Therefore all the courses have explicitly mapped the graduate attributes and correspondingly prepared course objectives and course outcomes. Further all postgraduate programs have been evaluated based on the course objectives and attributes. Equal weightage for CIE and SEE is given. Graduate attribute mapping is done for every subject taught at undergraduate level. Students' feedback is taken on regular intervals. Course outcomes are mapped to appropriate program outcomes and program specific outcomes through course and program articulation matrices.

The multidisciplinary fabric of Bangalore University, the STEM ecosystem, and employment opportunities of Bangalore places it as the most suitable destination to kick start the multidisciplinary four years undergraduate honors curriculum in Liberal Arts and Liberal Science along with its pre-existing popular four years undergraduate program in Life Sciences. Bangalore University is the first public university to begin its undergraduate program under NEP from December 2021. Under NEP, there is a shift from teacher-focused to learner-focused activities, i.e., from passive to participatory pedagogies characterized by flexibility in the system via Multiple-entry and Multiple-exit (1st year- Certificate, 2nd year- Diploma, 3rd year- Degree). The system facilitates the Continuation of education from the same level in any University/College through Academic Credit Bank. The student will complete graduation in 3 years. The optional 4th year is for Honours Degree, and if they complete the fourth year with Research, they will be directly eligible for Ph.D. Internship and Entrepreneurship are made a mandatory component of the curriculum.

Appointment of Guest faculty: Every year at the beginning of the academic year BU calls for the Guest faculty positions on the basis of the requirement put forth by respective departments through open advertisement in the News Papers. Selection criteria conform UGC API system. After initial scrutiny by the departmental HOD eligible candidates appear before the selection committee comprising of the Vice-chancellor, Dean, and HOD of the respective Departments. Candidates are selected on the basis of API score (out of 87.5) interview marks (out of 12.5). Social inclusivity is taken care of during the process of selection.

The university campus is secured with CCTV and high level security. There are separate Boys & Girls hostel (In-campus) for providing the safe environment to all students. Workshops, panel discussion and sensitization programmes are conducted to create awareness among girl students, female teaching and non-teaching staff. The text materials related to legal frameworks of gender equity and anti sexual harassments are distributed to all the students and staff. University has child care center. It has implemented transgender quota in University departments and affiliated colleges.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The university has well-planned multi-level strategies that are implemented from time to time to address the issues of learning levels. Mentoring is implemented at under-graduate and post-graduate level. Students are assigned with a teacher and senior students to get the academic support and speedup the learning. The induction training program conducted immediately after the admission. The orientation programmes will be conducted to provide basic understanding of the subject, professional possibilities and knowledge of skill requirements by the eminent academicians and professionals. Alumni are involved in motivating students. Since then, the students are trained by the respective faculty members during their course, catering to their needs and putting conscious effort to remove difficulties in studies.

The actual stratification of students into slow, average and advanced learners is based on their performance in the internal examination. Undergraduate courses are effectively implementing the mentorship and segregation of students into different learning levels. Teaching faculty, course coordinator and Head of the department takes up the responsibilities of providing necessary guidance and additional inputs to the students.

Special remedial classes are arranged for the slow learners before or beyond the regular class schedule on specific days for each course and individual attention is paid for improving the students' level of learning, problem solving and presentation.

Simultaneously, the needs of the average, progressive and advanced learners are taken care of by the concerned faculty through assignments, seminars, and more importantly peer-group discussions.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

Experiential learning, participative learning and problem solving methodologies are well adopted to ensure the holistic development of students and facilitate life-long learning and knowledge management.

Various courses offered at constituent colleges and Post graduate departments have incorporated participatory learning based on the demand of understanding the subjects. Students are allowed to participate in various training programmes by conducting special hands on training sessions and department level. Every post graduate course has the project work as part of curriculum. To enhance the participative learning, seminars, projects and model making are encouraged.

Participation in professional societal activities of IEEE, ACM, etc. for engineering, moot court for law and other relevant professional organizations activities. Soft skill training are imparted at regular intervals.

Industry interaction and the internships are made mandatory for the students. Social work, women studies, education students do regular field work and extension activities for experiential learning.

Industry projects and collaborations are undertaken to enrich students with pre-employment training. Periodical Guest lectures on topics relevant to employment skills by personnel from respective organizations/industry.

Experiential learning is ensured also through practical courses, encouraging students to take up innovative projects. Involving students in teacher's research work, organizing exhibitions etc.

Problem solving methodologies are adopted at every semester by incorporating quizzes, case study analysis, seminars and focus group discussions.

Due to COVID enforced online classes followed by lock down has enriched the use of ICT tools and online materials. All the faculty of Bangalore University have regularly taken online classes without compromising with curriculum requirements. Online live classes, discussions, demonstrations; project monitoring and practical orientation was given to the students extensively during this year. All the teachers are technically equipped the skills of handling various online platforms, learning management systems and tapping online resources. Teachers used MOODLE, Insert learning, Wakelet, Flip grid, Google classroom, Zoom, Google meet, Microsoft teams etc. Teachers have prepared video lectures, interactive slides and other activities to enhance the student engagement. Faculty have been provided with demonstrations and training to handle online classes. Even after resuming offline classes faculty are engaged with students learning through online platforms such as uploading the assignments, group discussions, online tests, interactions, discussions, sharing materials etc.

ICT enabled Teaching-Learning Process is supported with Regular Practical Sessions, access to Digital Library, Online Courses (MOOCS, NPTEL etc.), online journals, Online tests, Use of LCD projectors for seminars and workshops, productive use of educational videos, and accessibility of non-print material for students of different disciplines. Faculty and students find ICT tools indispensable as they are used to it.

2. Online Room Allotment & Online invigilation diary will reduce the error in entry of Absentees and ensure immediate result declaration
3. The University also found some irregularities in the result where outsourced (external) agencies were involved .Hence it has put a check on the process & developed foolproof digitization of evaluation & no error in totaling and other procedures.

Implementation of online Batch making for practical examination, online Examiner's allotment, online marks captured for UG/PG Practical Examinations has brought lots of transparency in the process of evaluation. For theory examinations, Room allotment, Invigilation dairy, packing details are all provided online. Marks cards/ certificates are issued to the students soon after examinations results. This process of transparency and faster delivery made acquiring knowledge more inclusive.

6.2.1 - The institutional Strategic plan is effectively deployed

The multidisciplinary fabric of Bangalore University, the STEM ecosystem, and employment opportunities of Bangalore places it as the most suitable destination to kick start the multidisciplinary four years undergraduate honors curriculum in Liberal Arts and Liberal Science along with its pre-existing popular four years undergraduate program in Life Sciences. Bangalore University is the first public university to begin its undergraduate program under NEP from December 2021. Under NEP, there is a shift from teacher-focused to learner-focused activities, i.e., from passive to participatory pedagogies characterized by flexibility in the system via Multiple -entry and Multiple -exit (1st year- Certificate, 2nd year- Diploma, 3rd year- Degree). The system facilitates the Continuation of education from the same level in any University/College through Academic Credit Bank. The student will complete graduation in 3 years. The optional 4th year is for Honours Degree, and if they complete the fourth year with Research, they will be directly eligible for Ph.D. Internship and Entrepreneurship are made a mandatory component of the curriculum.

Every year both teaching and nonteaching faculties who are permanent positions are expected to submit annual appraisal reports with documentation. Recruitment and promotions for teaching faculties happen in four ways.

Career Advancement Scheme (CAS): Every year on the basis of ratified UGC guidelines BU calls for application for in-service promotions for Assistant Professors, Associate Professors, and Professors. Qualified candidates submit their applications and the respective dean and IQAC director conduct the scrutiny. Eligible candidates appear before the screening/ Selection committee duly formed following UGC norms.

Appointment of Guest faculty: Every year at the beginning of the academic year BU calls for the Guest faculty positions on the basis of the requirement put forth by respective departments through open advertisement in the News Papers. Selection criteria conform UGC API system. After initial scrutiny by the departmental HOD eligible candidates appear before the selection committee comprising of the Vice-chancellor, Dean, and HOD of the respective Departments. Candidates are selected on the basis of API score (out of 87.5) interview marks (out of 12.5). Social inclusivity is taken care of during the process of selection.

Best Practice-1

Implementation of National Education Policy 2020 in the Bangalore University

Bangalore University is the first University in the country to introduce multiple exits, credit sharing four years Liberal arts UG courses in both colleges affiliated to the Bangalore University as well as in the University itself from the year 2021. On 28th October 2021 Orientation program for the degree, college Principals was conducted by the deans of all faculties. All PG dept have conducted subject-based orientation programs to the affiliated college teachers. Affiliated colleges are entrusted to conduct workshops on NEP for teachers, parents, and students.

Best Practice-2: Covid Vaccination Drive

To ensure equitable access to health by all the stakeholders of

the University community and to maintain a healthy campus amidst a global pandemic. Initially, University started the process for the vaccination for teaching and Non-teaching members of the University and for the International Students studying in the University. Subsequently, the facility was extended to all the members as vaccination was mandatory for entering the classroom or hostel. Eight Vaccination drives were conducted at Bangalore University in collaboration with BBMP. Almost 100% vaccination is achieved in the non-teaching, teaching, and students of Bangalore University. The Bangalore University has monitored the vaccination level at the affiliated colleges of Bangalore University before reopening. Although the majority of the students are residents of the hostels situated within the University, there were no instances of any clustering.
