3.4 Foreign National = 1 seat (candidate to be allotted by ICCR/any sponsoring organisation) (fee as prescribed by BUB)

3.5 Candidates under Sl. 3.2 to 3.4 above under supernumerary seats can opt. for any specialisation.

**Note:**

1. Bangalore University has no affiliated Law colleges from 2009 as all Law colleges affiliated to Bangalore University are now affiliated to Karnataka Law University and LL.M being a Professional course, the seats shall be treated and allotted as (1) Karnataka candidate category and (2) Non-Karnataka candidate category and are as stated below:

**(a) Karnataka Candidate category:**

Applicant/Candidates who has studied in one or more Government or Government recognized Educational institutions or Universities located in the State of Karnataka for a minimum period of seven academic years commencing from 1<sup>st</sup> standard up to qualifying examination either continuously or in broken period and acquired qualifying graduation from any recognised university.

**(b) Non-Karnataka Candidate category :** All candidates who do not fulfil the requirements as above (a) are Non Karnataka Candidates.

2. Supernumerary quota @ Sl. No. 13- Other Universities outside Karnataka and Sl. No. 18-Universities within Karnataka other than Bangalore University, in the Bangalore University Admission Notification dated: 13-07-2023 are revised as below.
3. All supernumerary seats except Non-Karnataka candidate under payment seat category, shall be Regular fee seats.
4. All supernumerary seats except Non-Karnataka candidate, Foreign National, Jammu and Kashmir, Kashmiri migrant and defence, shall be allotted only to the law graduates of Bangalore University.
5. Vacant Seats under G.M./Reservation category may be allotted to Non- Karnataka candidates with payment seat fees on merit basis only.
6. Person with disability (PWD) (2seats) are considered in regular fee matrix. Hence PWD under Supernumerary quota, Sl. No.4 in University admission notification dated 13.07.2023. shall not be considered

**4. Non Karnataka Candidates:** 5 seats \* under payment seats category ( Can opt for Any Specialisation)  
(\* as per approval of Academic council on 06.07.2023 and syndicate on 27.07.2023)

#### **5. Filling of Vacant Seats:**

##### **(i) Unfilled Hyderabad-Karnataka (H.K) Category seats :**

- GM(HK) seat shall be transferred to GM Category
- SC/ST / Cat-I (HK) seat shall be allotted to SC Category, if no SC candidate is available, then this shall be transferred to ST category, of no claimants in SC/ST, then to Cat-I.
- Cat-IIA/IIB/IIIA/IIIB /(HK) seat shall be allotted to IIA Category, In case if no candidates are available in IIA category, then this shall be transferred to IIB category, then to IIIA/IIIB on merit basis.

##### **(ii) Unfilled Person with Disability (PWD) seats :**

If one seat remains vacant, it shall be given to G.M. If two seats remains vacant one to G.M. and one SC/ST. In case there are no claimants in GM/SC/ST, one seat shall be give to Cat-IIA, One to Cat-I/ IIB/IIIA/IIIB on merit basis.

##### **(iii) Unfilled Reserved Category Regular fee Seats shall be transferred in the following order of Preference:**

1. SC seat to ST category
2. ST Seat to SC category
3. If no candidates are available in SC/ST category, only then the seats shall be transferred to Cat-I, Cat-IIA, Cat-IIB, Cat-IIIA, Cat-IIIB respectively.
4. After counting all the vacant seats in Cat-I, Cat-IIA, Cat-IIB, Cat-IIIA, Cat-IIIB those seats shall be allotted in the following order of preference, (one chance to each category in the merit order) (1) Cat-I, (2) Cat-IIA, (3) Cat-IIB, (4) Cat-IIIA, (5) Cat-IIIB & (6) General Merit

##### **(iv) Unfilled Reserved Category Seats in payment seat fee shall be transferred in the following order of preference :**

1. SC seat to ST category

**Note:** If no candidates are available in SC/ST category, only then the seats shall be transferred to Cat-I, Cat-IIA, Cat-IIB, Cat-IIIA, Cat-IIIB respectively.

2. After counting all the seats in Cat-I, Cat-IIA, Cat-IIB, Cat-IIIA, Cat-IIIB the seats shall be allotted in the following order of preference, (one chance to each category in the merit order) (1) Cat-I, (2) Cat-IIA, (3) Cat-IIB, (4) Cat-IIIA, (5) Cat-IIIB & (6) General Mart .

**(v) Refund of fees for candidates who paid Regular Fee:**

Candidate who cancel the seat are entitled for refund of fee as follows subject to the condition that the particular vacant seat is filled:

If he/she cancels the seat.


- (i) Within 10 days from the date of counselling / admission – 75% of tuition fee only.
- (ii) Between 11<sup>th</sup> day but before 30 days from the date of counselling / admission – 50% of tuition fee only.
- (iii) Others fees are forfeited.

**(vi) Refund of fees for candidates who paid Payment seat Fee:**

Candidate who cancel the seat are entitled for refund of fees as follows subject to the condition that the particular vacant seat is filled:

- i) Within 10 days from the date of counselling / admission – 75% of tuition fee+75% of Payment seat fee.
- ii) Within 30 days from the date of counselling / admission – 50% of tuition fee+50% of Payment seat fee.
- iii) Other fees are forfeited

**Note:** No refund is allowed beyond the said period.  
No refund, if the students have paid concession fees.
