Rules and Conditions for Hostel Admissions

- 1. All the hostels under the jurisdiction of Bangalore University are under the direction of the Director, Student Welfare Development Section, and Hostel Management Council.
- 2. The admission to the student hostels is subject to the regulations of Bangalore University.

3. Meal Timings in Hostels:

Breakfast : 8:00 am to 9:30 am
Lunch : 1:00 pm to 2:30 pm
Evening Snack : 5:00 pm to 5:30 pm
Dinner : 7:00 pm to 8:30 pm

- 4. All students who have gained admission to the hostel must strictly take their meals in the mess. During the designated meal times, students are required to have their meals in the mess without taking leave from the university or their respective colleges/departments. Any form of exemption will not be provided to students in the mess outside the specified meal times.
- 5. Only the available service facilities provided by the university will be offered. However, it is not considered as a right or entitlement by the students."
- 6. Only students who have been granted admission to the hostels will be provided with the facility of meals and room. It is strictly prohibited to bring unauthorized individuals to the rooms or provide meals to those who have not been allocated. Such actions may be considered an offense under the law, and legal proceedings may be initiated against students involved in harboring or providing accommodation or meals to unauthorized individuals. Parents may visit their children within specified hours upon obtaining permission from the chief warden.
- 7. Students are required to conduct themselves in a manner that does not cause harm to any property or assets within the hostel premises. Communicating with the opposite gender should be done in a respectful manner, and engaging in verbal or mental abuse or any form of misconduct may lead to legal consequences and disciplinary action.
- 8. Activities such as ragging, gambling, smoking, consumption of intoxicating substances, alcohol, and other unethical behaviors are strictly prohibited within the hostel premises. Students found engaging in such activities will be expelled from the hostel without any prior notice or warning.
- 9. In case any minor issues arise in the hostel premises, a group of two or three students associated with the chief warden can freely discuss and resolve the issue. If, for any reason,

this approach is not feasible, the matter should be brought to the attention of the director. Any public disclosure of grievances through media or any unauthorized communication is strictly prohibited without the permission of the university's registrar and vice-chancellor. If such incidents occur, the entry of the involved students (department and hostel) will be canceled.

- 10. Students are required to maintain cleanliness in their rooms, toilets, and bathing areas. It is prohibited for any student to use electrical appliances such as electric stoves, water heaters, and other electrical devices in their rooms.
- 11. Any cooking within the hostel rooms is strictly prohibited. Students are not allowed to cook anything in their rooms, and if any such activity is observed, the entry of those students will be canceled.
- 12. There is no entry for male students in the women's hostel, and vice versa. Students in the hostel are responsible for keeping track of and securing any valuables or money they possess. In case of loss or theft, neither the chief warden of the hostel nor the university will be held responsible.
- **13.** The wardens, directors, hostel managers, members of the Hostel Management Committee, Deans, and Vice-Chancellors can visit the hostel rooms without any prior notice.
- 14. The allocation of hostel rooms to students is typically done by the respective Chief Warden or the main administrative authority responsible for hostel management. In extreme and unavoidable circumstances, students may bring the need for room change to the attention of the Chief Warden, who has the discretion to consider and facilitate such requests.
- 15. In a hostel, when there is overcrowding, admission for additional students may be granted during such times. All students seeking admission to the hostels must comply with these conditions. If these regulations or conditions are not met, the admission to the hostel may be denied, and the hostel accommodation may be allocated to others.
- 16. Students must vacate the hostel within 3 days of completing their exams. During the vacation period, the room must be emptied, and the keys should be handed over to the chief warden.
